

Adirondack Scout Camps Counselor in Training Program

The Adirondack Scout Camps offers a Counselor in Training Program at Sabattis and Portaferry for Boy Scouts who will be 14 years of age by the start of staff week. Applicants must be First Class or registered with an active Explorer Post or Venture Crew.

During your session as a CIT you will experience assignments in all areas of camp operation. You must first complete a training program. Preference in selecting camp staff for future years will be determined by successful completion of your training and the CIT experience.

As you consider this opportunity, you and your parents should be aware that your pay will be the training you receive. Your room and board will be provided to you at no cost. Health and Accident insurance will be covered as well.

CIT's are normally the patrol leaders of your troops, teams, or posts. The CIT program does not want to deprive the unit of its leadership, so you are encouraged to attend Summer Camp with your unit. In order to do this we offer two three week sessions in addition to staff week. Staff Week is mandatory for all staff members including CIT's.

You and your parents should also understand that this is an opportunity to be associated with Scout Leaders and Camp Administrators who are particularly skilled, educated, mature individuals with special backgrounds. You will also be associated with other young people of high standards and character who have been screened and selected for this program.

If you are selected for this program and for some reason do not live up to the standards you will be asked to leave the program by the Camp Director with the approval of the Reservation Director.

As a CIT you will follow the rules and regulations of the camp at all times. These rules and regulations are defined in the Staff Manual that you will receive.

Parents, The Adirondack Scout Camps are inspected on a regular basis by both the New York State Health Department and the Boy Scouts of America. We are issued a permit to operate a children's camp by both these agencies and enjoy a successful relationship with both.
